WHY CAN'T I START MY OWN SCHOOL AND WHY DO I NEED TO GO WITH CORNERSTONE?

To start a school and have it running is a task and very expensive. When you think of curriculum and accreditation only you want to give up. To design a curriculum for one class costs about \$1500.00, time

that by 40 courses for a bachelor program. What if you have at five bachelor programs? Then the State of Florida or your particular state charges you \$250.00 per course to review them and accreditation charges from \$500.00-\$900.00 depending of the level of course to review one course for you. Regional accreditation cost about two million dollars to start, National accreditation costs about one million and half to start, and private accreditation (which we have) cost about five hundred to eight hundred thousand dollars to start.

HOW ABOUT ACCREDITATION DOES MY SCHOOL RESPONSIBLE ANY SHARE COST?

If you run a branch campus, you have no share cost. If on the other hand, your school has its own name, there is a shared cost has been stable to \$540.00 per year that you pay. This fee has been study for the past three years and will remain as such until any increase from the accrediting agency.

If you buy a textbook of 120 pages and pay someone \$12.00 an hour to read the book from cover to cover and to design a curriculum for that textbook, it would take him/her 90-100 hours, it would cost you \$1080.00 for 90 hours. We are talking about one course. Then that course must be reviewed by the state mentioned above and by the accrediting agency that accredits you. These costs I mentioned do not include all the other expenses to make the course available pay rent to your local school to keep the book.

TALKING ABOUT ACCREDITATION, WILL CREDITS TAKING AT CORNERSTONE MAIN CAMPUS OR AT MY SCHOOL TRANSFER TO OTHER SCHOOL OF THEIR CHOICE?

Accreditation is a voluntary process in the US conducted by peer review of those who submit to it. No federal or state laws require a school neither to be accredited nor to force another school to accept credit from another institution. Acceptance of credits is purely at the discretion of the receiving institution. Money plays a very important part of the game. Institutions reserved their right not to accept credits from other schools because "they lose money" they say. They will quickly reject another school and blame it on "not being accredited." According to USDE, credit should be evaluated based on content but not accreditation.

From the US Department of Education, "Accreditation does not provide automatic acceptance by an institution of credit earned at another institution, nor does it give assurance of acceptance of graduates by employers. Acceptance of students or graduates is always the prerogative of the receiving institution or employer. For these reasons, besides ascertaining the accredited status of a school or program, students should take additional measures to determine, prior to enrollment, whether or not their educational goals will be met through attendance at a particular institution. These measures should include inquiries to institutions to which transfer might be desired or to prospective employers and, if possible, personal inspection of the institution at which enrollment is contemplated.

THOSE CURRICULUMS YOU HAVE MENTIONED, HOW DOES THAT WORK IF I WERE TO BECOME AFFILIATE WITH CORNERSTONE?

Each time you will teach a class, you will receive a **master copy** of the class material, including the text book, tests and keys, except the syllabus because we leave that at your discretion or the instructor who is going to teach the class. This master copy will be copyrighted but will include copy privilege to duplicate only for teaching at your school just Cornerstone receive this said duplicate privilege to do so. WHAT ABOUT THE STUDENTS AT MY SCHOOL/EXTENSION, HOW DO THEY GET THEIR BOOKS?

Textbooks are expensive (French textbooks are even more expensive). Just like any other school, the students purchase their own books from us or from other bookstores. WHERE WILL AN EXTENSION FIND ITS STUDENTS?

Everywhere! Jesus trained his disciples for three intensive years before he send them out. Most scholar evaluate that three years to a master or doctorate comparing to our current time frame for degree. Education and training should not be compromised in ministry. A church should encourage its broad members to go to schools but must require its ministry staff (teachers, ministers, leadership team) to go to school.

Most pastors have a network of pastors and churches can draw students from. Ad can be place on papers, bulletin board, and elsewhere. Radio and TV advertising can be costly so be wise.

WHO WILL TRAIN THE STUDENTS?

In most cases you'll be the first to teach! You must have at least a master degree in a biblical field. If not, you'll need to find someone qualified with such degree to train your students. When you start having lots of students, you'll definitely have to hire others to teach. A doctoral degree is preferred and a bachelor degree is accepted in circumstances where the person holds another degree from a secular field. A person with only an honorary degree is not qualified to teach under no circumstances.

HOW LONG WOULD IT TAKE MY STUDENTS TO COMPLETE THEIR TRAINING?

These are non-degree programs issued for theology or for Biblical Studies to lay people who teach Church Bible School)

In addition, Branch Extension Bible schools may design their own sequences of courses, which accomplish their unique purposes.

HOW MANY STUDENTS ARE REQUIRED TO BEGIN MY CHURCH CENTERED EXTENSION BRANCH BIBLE SCHOOL?

You could actually start a class with five to six interested students who are willing to apply themselves to study. In fact, you can apprentice students one-on-one. Classes seem to have the best flow dynamic if there are a minimum of eight to twelve in the room, so we do try to aim for this, if possible.

CAN PARTICIPANTS AUDIT OR TAKE COURSES FOR CREDIT OR NO CREDIT?

CCU'S courses provide the opportunity for Spirit-anointed mentoring, and most courses can be opened to the entire congregation. In a typical class, you may have students who are auditing the course sitting next to those who are taking the course for credits. If you are offering the teaching sequence on a Wednesday evening, you will even have people who are simply sitting in and not auditing the course or taking it for credit.

This allows you to meet the needs of each student where he is. However, students should be encouraged to put forth the extra effort to take the courses for credit. This demands more of them, and they in turn receive more from the course. Challenging people to stretch themselves and speeds their growth.

WHAT DO STUDENTS DO WHEN AUDITING?

The auditing student is free to do as little or as much of the course work as he desires. Minimally, he will be encouraged to carefully read and personalize the primary text used in the course, and write a paper summarizing how God has changed his life as a result of the course. He does not take tests and receives no course grade. Each church campus may set any auditing fee desired. Don't forget:

In general, we do not value what costs us nothing. Probably a minimum of \$180.00 should be charged when students audit a course, including most text books).

WHAT SHOULD STUDENTS DO WHEN TAKING COURSES FOR CREDIT?

The for-credit student is to read all required texts (generally one-two books per course), complete all assignments, take all required tests, and receive a course grade.

HOW MUCH MONEY AND TIME WILL IT TAKE A STUDENT TO COMPLETE THEIR STUDY?

This question might be the first one you'll be asked. It always seems, it's the only two things that concerned most of what we would call drive thru students. It is the church's and the pastor's responsibility to teach their members to not devaluate the most precious teaching on earth with an eternal reward. We can't put a price tag on education and study is a lifelong project.

Nonetheless, the church may set the tuition fee accordingly or use CCU's current tuition with a purpose to build its Bible school and pay its instructors. Churches often charge from \$175 to \$200 per course for noncredit students and \$240.00 per credit, and sometimes on a sliding scale depending on family income

and number of dependents. Rather than charge tuition, some Church-centered Bible schools have simply taken up a weekly offering to go as a gift to the instructor. This also seems to work well.

WHAT ABOUT THE PART-TIME STUDENT?

Most students will be part-time, enrolling in only one or two courses offered by your local church at a time.

WHAT ABOUT THE FULL-TIME STUDENT?

This student takes at least five courses each quarter one course at a time, completing 10 for a one-year period. He will take some courses:

- a) In the classroom setting at the extension branch church centered Bible school;
- b) Through one-on-one instruction with instructors from the church-centered campus. This occurs when the student wants to take a course that is not being offered in a classroom setting, and there is an instructor in the extension branch church centered Bible school that is willing to provide the mentoring on a one-to-one basis.
- c) Directly from CCU with CCU'S faculty who are not a part of the particular extension branch church-centered Bible school. This occurs when the student wants to take a course not being offered in a classroom setting, and there is no instructor in the extension branch church-centered Bible school who is willing or able to provide the mentoring on a one-to- one basis. Therefore, the student works directly with CCU for this course.

CCU'S curriculum offers the opportunity for small group interaction, pastoral oversight and guidance, fellowship, teaching, hands-on experience in the classroom and practical in the local church. Thus, CCU'S training is active, rather than passive. The more active the student is in the learning process, the faster he will grow.

CCU'S courses help the local church disciple and train its members, under the church's pastoral oversight, while incorporating the church's particular theological and spiritual emphases. No additional buildings need be built or heated, and there is little additional expense.

Truly, the church-centered extension branch Bible School is an idea whose time has come.

Church-centered extension branch Bible schools may run key foundational courses regularly, thus insuring that all current and new church members receive thorough basic training and discipline.

This helps all new congregational members become fully established in Christ, without the necessity of the senior pastor teaching the same basic themes over and over.

At the same time, the student who desires can be working toward one of several accredited degrees.

WHAT ABOUT THE SPIRIT-ANOINTED DISCUSSION GROUPS?

Since CCUS course syllabuses are developed for the extension branch student, all required cassettes, videos, and reading of required materials wherever applied may be done by the students on their own during the week. This allows the coming together of students to be considered a facilitator group rather than a class. That means the focus of these times can be on discussing the students answers to the week work, any questions they have, things they feel God has spoken into their lives, and any difficulties they are experiencing in appropriating life changes the lesson has called for.

The instructor can serve as a facilitator of a lively Spirit-anointed discussion, as he discerns what God wants to do among the gathering and cultivates the flow and anointing of the Holy Spirit in a corporate discussion.

CAN STUDENTS EXPERIENCING GOD IN THE SMALL GROUP?

The group meeting need not be a typically instructional time, but can instead be a sharing of revelation between the facilitator and the group. This is ideal especially if you are running courses in the home cell group or Sunday school time slots. The discussions can be lively and kept to 45 minutes or so. Since the participants have all done study, reading, and prayer on the topic at hand, the group time becomes a sharing of revelations rather than a sharing of ignorance (i.e. discussions for which no one is prepared). And, since it is not a lecture, the group is not limited by the communication skills of the group leader.

CAN I OFFER GRADUATE PROGRAMS THROUGH MY EXTENSION?

Extensions are allowed to offer programs up to Bachelor. Extensions interested in offering graduate studies must be in operation for two years, and be in good standing with CUU's extension program. Furthermore, an extension must prove that the instructors who to teach are qualified to teach and are the holder of higher degree in respective field. All extensions that have students willing to pursue graduate studies and have not met the two-year criteria may enroll students directly with Cornerstone's main campus or at distance learning program.

WHAT ABOUT DISPUTE AND HOW THE MAIN CAMPUS HANDLES BETWEEN THE STUDENT AND THE BRANCH CAMPUS?

Every branch extension is responsible to handle their own conflict. If the branch extension is unable to resolve the conflict, either the student or the branch campus presidents can request the main campus to intervene. After hearing the case, the main campus may do one of the followings:

- a. rule in favor of the branch
- b. rule in the student favor
- c. suggest that the student be transferred to the main campus

CAN THE BRANCH EXTENSION REFUSE TO TRANSFER THE STUDENT TO THE MAIN CAMPUS TO FURTHER THEIR EDUCATION?

Every student under either extension is a CCU student according to state and accreditation regulation. However, if the student's financial obligation is not met, the extension may refuse to release the student record to the main campus or to any other institution until the financial responsibilities of such student is met. If otherwise, the extension cannot.

Example1. Say you can enrol...

- 40 students per class and you charge \$140.00 per student.
- You would have collected \$5600.00 per course/class
- \$2240.00 would be our compensation
- \$3360.00 would be your net compensation

At your discretion, you can charge more or less than \$140.00 per course. You can increase or decrease the tuition based on quantity.

Example 2. If you enrol...

- 60 students and you charge \$240.00 per student. You would have collected
- \$14400.00 /classes
- \$5760.00 would be CCU's compensation
- \$8640.00 would be your net compensation for just one class

You can do the math for any number of students you need
